



# LRA TAKE IT TO THE DISTRICT – GENERAL TALKING POINTS

#### **General points:**

- Introduce yourself, where you live or work in the district, and as a representative of the Lupus Research Alliance.
- Ask if they are familiar with lupus, and know what lupus is or how it affects the body. Be prepared to briefly describe lupus as a serious potentially life-threatening autoimmune disease in which the immune system can attack any part of the body including kidneys or lungs.
- Our asks are:
  - \$15 million for the Department of Defense's Lupus Research Program
  - \$51 billion for the National Institutes of Health (NIH)
  - Support for the Lupus Accelerating Breakthroughs Consortium (Lupus ABC)

#### Lupus Research at the Department of Defense (DoD)

Please support a final bill that includes at least \$15 million for the Department of Defense's Lupus Research Program in Fiscal Year 2025.

- The number of active-duty service members and veterans diagnosed with lupus is increasing because more women and people from minority populations are serving in the military.
- The DoD's Congressionally Directed Medical Research Program (CDMRP) facilitates novel approaches to biomedical research that fill research gaps by funding high impact, high risk, and high gain projects.
  - Funding for the Lupus Research Program is not enough to meet the current demand. Just 18% of grant applications are awarded federal funding, demonstrating the need for increased investment in this program.

#### Funding for the National Institutes of Health (NIH)

Please support a final bill that provides NIH with \$51 billion in Fiscal Year 2025.

- The NIH is the largest public funder of medical research in the world, and the agency's research has helped fund lupus breakthroughs.
- Despite highly promising results, the overall success rate for researchers obtaining an NIH grant remains low at 20%.
  - Without the support NIH can provide, lupus research is drastically slowed, sometimes stopping entirely, and information gleaned from early work is often lost.

#### Lupus Accelerating Breakthroughs Consortium

Please support the work of a public-private partnership with the FDA called the Lupus Accelerating Consortium that accelerates development of new therapies and include specific language in the final Fiscal Year 2025 Ag-FDA report.

- The Lupus Accelerating Breakthroughs Consortium (Lupus ABC) is the first public-private partnership with the FDA that brings together researchers, the biopharmaceutical industry, patients, and other lupus stakeholders to develop solutions to barriers that will accelerate development of new therapies.
  - This partnership ensures lupus patient's voices are heard and is central to the development of new therapies.
- We ask that Congress support the below report language in the final Fiscal Year 2025 Ag-FDA report.
  - Lupus —The Committee is aware of barriers that have long affected the development of therapeutics for lupus, a disease that disproportionately affects women of color. The Committee is pleased that FDA

created the Lupus Accelerating Breakthroughs Consortium (ABC), a public-private partnership bringing together researchers, the biopharmaceutical industry, patients, and other lupus stakeholders to develop solutions to identified barriers that will accelerate development of new therapies. The Committee encourages FDA to continue this engagement and requests updates on efforts to improve drug development and accelerate more safe and effective treatments for people with lupus.
